Adoption of the 2023 Safety Culture Assessment Guidelines for Electrical Corporations

The Office of Energy Infrastructure Safety (Energy Safety) will hold a public meeting on Wednesday April 12, 2023, from 11:00 am to 12:00 pm on the adoption of the [2023 Safety Culture Assessment \(SCA\) Guidelines for Electrical Corporations \(2023 SCA Guidelines\)](#).¹ This meeting will allow Energy Safety to present an overview of the changes made to the 2022 SCA Guidelines for 2023 and consider adoption of the 2023 SCA Guidelines. The meeting will also allow the public to comment on the Draft 2023 SCA Guidelines.

Energy Safety invites stakeholders, including individual members of the public and local and regional agencies, boards, tribes, and commissions, to comment on the Draft 2023 SCA Guidelines. Energy Safety is also accepting written public comments on the Draft 2023 SCA Guidelines prior to the public meeting.²
