

ENERGY SAFETY TO HOLD VIRTUAL PUBLIC WORKSHOP ON THE 2023-2025 WILDFIRE MITIGATION PLAN SUBMISSIONS OF SMALL AND MULTI-JURISDICTIONAL UTILITIES

The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public workshop on 2023-2025 Wildfire Mitigation Plan (WMP) submissions of small and multi-jurisdictional utilities (SMJUs) on Friday, June 16, 2023. The workshop will consist of three panels comprised of utility representatives and industry experts.

Members of the public, stakeholders, and local and regional agencies, boards, tribes, and commissions are invited to participate in the workshop. Energy Safety is also accepting written public comments on the 2023 SMJU WMP submissions. Public comments on the electrical corporations' submissions are due by June 29, 2023.¹
