1. Section 4000.

Section 4000, subsection (b) provides definitions. The definitions, “Area of Continual Excavation Agreement (Agricultural Operations)” and “Area of Continual Excavation Agreement (Flood Control Facilities)” are being amended to reflect updated website addresses and version numbers of incorporated forms.

9. Incorporated Reference, Form No. ACE Agreement 01

This incorporated reference, Area of Continual Excavation Agreement--Agricultural Operations, is a mandated form for an agreement between parties regarding excavation and agricultural operations. The form has been updated with a new Board logo, corrected references to relevant regulations, and a new version number.

- In 2022 the Board updated its logo. The logo is displayed on the ACE Agreement 01. The Form has been updated to include the new logo and delete the old logo.
- The ACE Agreement 01 references regulation sections 4300-4302. Section 4300 is not relevant to this form as it is the chapter effective date. There are no sections between section 4300 and section 4302 and section 4302 does not exist. The form should reference sections 4002 and 4351. Section 4002 incorporates the form into regulation and section 4351 mandates the use of the form in certain circumstances.

Sections 4350 and 4351 are not relevant to this form as they relate to agriculture operations. The form should reference sections 4002 and 4361. Section 4002 incorporates the form into regulation and section 4361 mandates the use of the form in certain circumstances.
