



2025 WILDFIRE MITIGATION PLAN UPDATE

GROUP 2 WORKSHOP

Public Meeting Notice

The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public workshop on Wednesday, July 31, 2024, on the 2025 Wildfire Mitigation Plan (WMP) Updates from Liberty Utilities (Liberty), PacifiCorp, Horizon West Transmission (HWT), Trans Bay Cable (TBC) and LS Power Grid California (LS Power). Collectively, these electrical corporations are referred to as “Group 2.” The workshop, from 9 a.m. to 3:30 p.m., will include a presentation from each Group 2 electrical corporation and an opportunity for workshop participants to ask questions and provide comments.

Energy Safety invites members of the public, local and regional agencies, boards, tribes, commissions, and other stakeholders to participate in the workshop. Attendees are encouraged to send questions for electrical corporations related to 2025 WMP Updates to Dakota Smith at dakota.smith@energysafety.ca.gov by 5 p.m. Monday, July 29, 2024. Energy Safety is also accepting written public comments on the electrical corporations’ 2025 WMP Updates. Opening comments for Group 2 electrical corporation submissions are due August 12, 2024.¹
