Day 1: Vegetation Management Workshop Agenda

This workshop will review and discuss California's variable ecosystems and the varying drivers of fire behavior to inform utility vegetation management practices. Speakers will discuss the state-of-the-art technology for monitoring vegetation health and forecasting risks across spatial and temporal scales.

1. Panel 1: Understanding Differences in California's Fire Regimes

• Dr. Jon E. Keeley – Research Scientist, U.S. Geological Survey (USGS), Sequoia National Park

Dr. Keeley's research focuses on ecological and social impacts of wildfires and other aspects of plant ecology. Dr. Keeley has published over 350 publications on fire and plant ecology.

Dr. Keeley will discuss the variation in the drivers of fire behavior across different vegetations types and the importance of understanding the ecosystem where utility infrastructure operates.

2. Panel 2: Emerging Technology for Wildfire Monitoring and Modeling

• Dr. David Marvin – Co-Founder and CEO, SALO SCIENCES

Dr. Marvin is an expert in forest ecology, remote sensing, and machine learning.

Dr. Marvin will describe the California Forest Observatory, its underlying datasets, and applications. He will further discuss tree mortality and fire hazard modeling data products for California.

• Kevin Hiers - Director of Fire Science Applications, Tall Timbers Research Station

Mr. Hiers has worked in fire management and prescribed fire science for 27 years, and has published over 100 peer-reviewed articles. He was in the US Air Force Wildland Fire Program Manager at Eglin AFB and now partners with various agencies to develop improved methods and practices for wildfire mitigation and prescribed fire application.

Mr. Hiers will discuss developments of high resolution 3-D fuel and fire models, and wind effects on vegetation for applications to fire risk and resilience.
