




2021 WMP Timeline



Recommendation 1: Standardized data across utilities

Data taxonomy & schema to ensure

- 1. Consistent formatting
- 2. Streamlined reporting
- 3. Cross-utility comparison



Recommendation 2: Consistent & transparent submissions


- 1. Consistent format to track progress
- 2. WMP completeness checklist
- 3. Quarterly data submissions tied to annual WMP update



Recommendation 3: Local outcome & outreach metrics

Higher spatial granularity for:

- 1. PSPS & wildfire metrics (see D.20-05-051)
- 2. Community outreach metrics (see D.20-03-004)
- 3. Initiative data



Recommendation 4: Ratepayer impact metrics

- 1. Separate control (i.e., ongoing) initiatives from those started in WMP cycle
- 2. Report impact to ratepayers from new initiatives & expansions to controls



Recommendation 5: Goals vs. objectives vs. targets

Goal – All utilities aligned with WSD goal Objectives – Utility-specific "milestones"

Program targets – Metrics to track progress



Recommendation 6: Citing state and federal rules

Each WMP program's narrative includes:

- 1. State and federal rules associated
- 2. State and federal proceedings associated



Recommendation 7: IOU training practices & worker qualifications

IOUs required to disclose:

- 1. Current training practices
- 2. Gaps in wildfire mitigation expertise
- 3. Plans to fill gaps



Recommendation 8: IOU contact info, expert quals & citations

IOUs required to report:

- 1. Contact info for people executing WMP [redacted]
- 2. Credentials of experts referenced [in appendix]
- 3. Citations to research referenced [in appendix]



Recommendation 9: Separate PSPS section

- 1. New section specific to PSPS
- 2. PSPS reporting requirements consolidated
- 3. Additional PSPS reporting required
