# **NOTICE OF PROBABLE VIOLATION**

Dear: Mr. Miranda,

The Board has concluded an investigation of an incident on the above date, time and location and has determined that Kana Pipeline Inc. violated Article 2 of Chapter 3.1 of Division 5 of Title 1 of the California Government Code as follows:

Gov't Code § 4216.3 (b): If the field marks are no longer reasonably visible, an excavator shall renotify the regional notification center with a request for remarks that can be for all or a portion of the excavation. Excavation shall cease in the area to be remarked. If the delineation markings are no longer reasonably visible, the excavator shall redelineate the area to be remarked. If remarks are requested, the operator shall have two working days, not including the date of request, to remark the subsurface installation.

Kana Pipeline was using an excavator to dig out a sewer manhole for a new development when their employees struck a forced sewer main on 1/13/2021. Prior to the damage, Kana Pipeline had verbally requested that the City of Chino come back out and remark the sewer main because the marks were no longer visible. Kana did not, however, request a remark through the one-call center pursuant to Gov't Code 4216.3(b), and City of Chino employees did not remark the forced sewer main. Kana Pipeline began excavation even though the City of Chino had not remarked the line, in violation of Gov't C 4216.3(b).

(Sections 4216 et seq.) is punishable by a maximum penalty of \$10,000, or \$50,000 for knowing and willful violation.

A Corrective Action of mandatory completion of the Board's education course is being imposed. Please see https://dig.fire.ca.gov/education-course for more information.

The proposed sanction reflects the nature and gravity of the violation and takes into consideration the Respondent's history of prior offenses, cooperation with the investigation and demonstration of his/her intent to comply with Government Code section 4216 et seq in the future. Kana Pipeline took responsibility for the incident that occurred on 1/13/2021 and has expressed a willingness to make changes to their excavation safety protocols. Kana Pipeline had no previous violations with the Board and fully cooperated with the investigation by providing access to personnel, providing statements, incident reports and photographic evidence.

This matter will be referred to the Contractors State License Board with a recommended penalty of mandatory completion of the Board's education course.

The California Underground Facilities Safe Excavation Board will act on this notice of probable violation in a future meeting.

You may contest this notice by responding to this notice promptly. Please see attached instructions on completing and submitting your response for options available to you. Your response to this notice must be received by the California Underground Facilities Safe Excavation Board no later than September 17, 2021.

Your request to reschedule a hearing may be granted no more than once and only for good cause. During your hearing, conducted pursuant to Section 4253 of Title 19 of the California Code of Regulations, Board staff will present the basis for your notice of probable violation. Kana Pipeline was using an excavator to dig out a sewer manhole for a new development when their employees struck a forced sewer main on 1/13/2021. Prior to the damage, Kana Pipeline had verbally requested that the City of Chino come back out and remark the sewer main because the marks were no longer visible. Kana did not, however, request a remark through the one-call center pursuant to Gov't Code 4216.3(b), and City of Chino employees did not remark the forced sewer main. Kana Pipeline began excavation even though the City of Chino had not remarked the line, in violation of Gov't C 4216.3(b). Kana Pipeline did not pothole to find the sewer main prior excavation on 1/13/2021. Kana Pipeline stated that they knew the sewer main was there, but believed it was 20 feet deep. Kana Pipeline hit the sewer main 5'-6' feet below grade.

As there were no visible marks, there was no tolerance zone, so Kana Pipeline is not in violation of Gov't Code 4216.4(a)(1): failure to determine the exact location before using power tools in the tolerance zone. Though the City of Chino could have taken actions to address Kana Pipeline's remark request, the City's obligation to remark under Gov't Code  $4216 \ et \ al.$  is to do so in response to requests made through the one-call center, which Kana Pipeline did not do. Therefore, the City of Chico is not in violation of Gov't C 4216.3(b).

#### Scene Description:

Excavation site was a residential development site at the corner of Mayhew Ave. and Bickmore Ave. Chino, CA.

#### **Summary of Investigation:**

On 1/13/2021, the California Underground Utilities Safe Excavation Board was notified by Enrique Miranda (Miranda) of Kana Pipeline that they had damaged a sewer main in Chino, CA. The investigation was assigned to investigator John Benane (Benane).

A search of the Contractor's State License Board website showed that Kana Pipeline has a valid license 461487 (**Ex-1**) in the State of California.

On 1/21/2021, Investigator Benane contacted DigAlert, via email to request ticket number A202520351. Benane received the ticket from DigAlert (**Ex-2**).

On January 21, 2021, Investigator Benane contacted the City of Chino Department of Public Works to obtain information about the incident. Benane was informed by Ben Orosco (Orosco), City of Chino Assistant Public Works Service Manager, that the individual he needs to speak with about the incident was Rick Lopez, City Inspector.

On 7/27/2021, Investigator Jason Corsey (Corsey) conducted an interview of Miranda, Director of Safety for Kana Pipeline, Mike Lockwood (Lockwood), Foreman Kana Pipeline and Havier Herrera (Herrera), Excavator Operator Kana Pipeline via Teams virtual platform. Miranda stated that Kana Pipeline had two (2) separate damage incidents on this project, one occurred November 11, 2020 and the second occurred January 13, 2021. Both incidents involved a sewer main owned the City of Chino.

#### First Damage Incident - 11/20/2020

In the interview regarding the incident that occurred on 11/20/2020 (**Ex-3**), I asked Miranda to explain the type of work Kana Pipeline was performing when the incident occurred and what in his opinion was the cause of the damage. Miranda stated that Herrera who was also present during the interview was operating a 75 thousand-pound excavator, excavating a trench line to remove a corrugated metal pipe riser when he hit a forced sewer main with the bucket of the excavator. Miranda stated that the line was marked, and the trench was already open. Miranda further stated and Herrera agreed that Herrera knew the line was there, but that his attention was temporarily diverted, and he hit the forced sewer main with the bucket of the excavator causing a sewage leak. Miranda stated and Herrera agreed that the incident was the result of operator error and that Kana Pipeline takes responsibility for the incident.

Miranda stated that after the hit, Kana Pipeline contacted the City of Chino Public Works to advise them of the damage. Miranda further stated that the City of Chino Public Works came out with vacuum trucks to clean up and haul off the spilled sewage and repair the damaged line.

#### Second Damage Incident – 1/13/2021

In the interview regarding the incident that occurred on 1/13/2021 (**Ex-4**), I asked Miranda to explain the type of work Kana Pipeline was performing on this project and what in his opinion was the cause of the damage the occurred January 13, 2021. Miranda stated that Lockwood who was also present during the interview was the foreman for Kana Pipeline on this section of the job. The excavator operator on this job was Rogelio Becerra (Becerra) who was not present for the interview.

Miranda stated that Becerra was there to dig a sewer manhole out for the installation of a sewer in a new development. He stated that Becerra had not worked on this section of the project until the day the incident occurred. He was brought over because he operated a large 160 thousand pound excavator. Miranda stated and Lockwood agreed that Kana Pipeline knew where the line was because it had been previously marked, but due to time and all the work being done in the area the marks were no longer visible. Miranda stated that Lockwood made several requests over several days to have the line remarked. I asked Miranda who they contacted to have the line remarked. Miranda stated that they contacted the City of Chino who owns the utility and spoke with an inspector and IEUA the company who operates the line to have it remarked. Miranda Stated that after several attempts the Sewer Main was never remarked.

Miranda stated that they knew where the sewer main was and that it was roughly 20 feet deep, so Lockwood directed Becerra to start to dig with the excavator. Miranda further stated and Lockwood agreed that after instructing Becerra to start excavating Lockwood walked to the opposite side of the jobsite and wasn't close by to direct Becerra. Miranda stated that while digging for the manhole, Becerra was about 5'to 6' feet below grade when he hit the 16" inch forced sewer main. Miranda stated that after the sewer main was hit, Lockwood dug a pond to contain the sewage so it would not drain off to nearby vegetation and roads. Miranda stated the City of Chino was again contacted and they came out with vacuum trucks to clean up the sewage and repair the damage.

I asked Miranda if Kana Pipeline potholed the line prior to excavation. Miranda stated that no Kana Pipeline did not pothole the line since they believed they knew where it was and expected it to be 20 feet deep.

Lockwood stated that he felt some responsibility for the damage because he believed he was not 100% clear with Becerra about the actual location of the line.

I requested that Miranda email me copies of Kana Pipeline reports of damage and photos he had shown me on Teams. Miranda supplied Kana Pipelines damage reports with photos for the incidents that occurred on 11/20/2020 (**Ex-5**) and 1/13/2021 (**Ex-6**).

I also asked Miranda to provide site plans for the portion of the project they were working on the date of the incident. Miranda had Lockwood forwarded photos of the site plans Kana Pipeline had been provided for the project (**Ex-7**). I asked Lockwood who provided the plans him. Lockwood stated that he was given the engineering plans in a Kana Pipeline project meeting.

Lockwood further stated that he could not be sure who provided them to Kana Pipeline because he is not part of those larger meetings.

#### **Rick Lopez – City of Chino**

On July 28, 2021, I interviewed Rick Lopez (Lopez), Inspector for the City of Chino about damage incident involving Kana Pipeline that occurred on 1/13/2021 to the city's sewage main (**Ex-8**).

I asked Lopez to describe in his own words what occurred on 1/13/2021. Lopez stated that this was a big development project with a lot going on. Lopez further stated that Kana Pipeline was digging out a manhole for the installation of a new sewer line for a new development. Lopez stated that the Kana Pipelines excavator while digging for the manhole hit their 16" forced sewer main causing a leak of sewage.

I asked Lopez if Kana Pipeline had called for a remark of the sewer main for this particular part of the job. Lopez stated that he did receive a verbal request to have the sewer main remarked and that he forwarded the request verbally to Joe Cavalier (Cavalier). Lopez stated that Cavalier was the crew leader for the City of Chino sewer department and would be in charge of having the line marked. Lopez further stated that after he relayed the request to Cavalier, he never heard anything else from Kana Pipeline about the remark request and assumed it had been completed. Lopez again stated that this was a big project with a lot going on, so he moved on to other things.

When I asked Lopez for Cavalier's contact information, he stated that Cavalier no longer works for the City of Chino. Lopez stated that it should be noted that there are (2) 16" sewer mains running side by side and that they were clearly shown on the plans Kana Pipeline had been given. I asked Lopez about the depth of the sewer mains and he said that the grading was rough in several areas of the new development worksite, so it would be difficult to accurately determine the depth from the plans.

I asked Lopez who IEUA was and what their role is. Lopez stated that IEUA was the Inland Empire Utility Agency (IEUA) and that they run the sewage plant, but the lines belong to the city. I asked Lopez if IEUA would be responsible for marking the line and he stated no they wouldn't have marked the line.

#### **Investigative Findings**

#### KANA PIPELINE

Gov't Code 4216.3(b) - If the field marks are no longer reasonably visible, an excavator shall renotify the regional notification center with a request for remarks that can be for all or a portion of the excavation. Excavation shall cease in the area to be remarked. If the delineation markings are no longer reasonably visible, the excavator shall redelineate the area to be

remarked. If remarks are requested, the operator shall have two working days, not including the date of request, to remark the subsurface installation.

Kana Pipeline stated in an interview that prior to hitting the sewer main on 1/13/2021, they had requested that the City of Chino come back out and remark the sewer main because the marks were no longer visible. Kana did not, however, renotify DigAlert with their remark request. Kana Pipeline acknowledged in the interview that they began excavation even though the City of Chino did not come out to mark the line after their request. Kana Pipeline is in violation of Gov't Code 4216.3(b).

Gov't Code 4216.4(a)(1) -Except as provided in paragraph (2), if an excavation is within the tolerance zone of a subsurface installation, the excavator shall determine the exact location of the subsurface installation in conflict with the excavation using hand tools before using any power-driven excavation or boring equipment within the tolerance zone of the subsurface installations.

Kana Pipeline acknowledged in an interview that they did not pothole to find the sewer main prior excavation on 1/13/2021. Kana Pipeline stated that they knew the sewer main was there, but believed it was 20 feet deep. Kana pipeline hit the sewer main 5'-6' feet below grade.

As the line was not remarked, there was no tolerance zone. Therefore, Kana Pipeline is not in violation of Gov't Code 4216.4(a)(1). Had the City of Chino remarked the line, however, Kana Pipeline likely would have still hit the facility, as Kana Pipeline employees were mistaken about its depth and used a large excavator prior to determining conflict with hand tools (pursuant to Gov't Code 4216.4(a)(1)), vacuum excavation (pursuant to Gov't Code 4216.4(a)(2)), or permissible power tools (pursuant to Section 4501, Title 19, California Code of Regulations). Had the City of Chino remarked and Kana Pipeline used the large excavator in the tolerance zone prior to determining conflict, the City would have been in violation of Gov't Code 4216.4(a)(1).

Kana Pipeline was not in violation of Gov't Code 4216 *et al.* for the damage occurring on 11/20/2020, as the damage occurred after the Kana had already exposed the line to determine its exact location pursuant to Gov't Code 4216.4(a)(1).

#### CITY OF CHINO DEPARTMENT OF PUBLIC WORKS

City of Chino Inspector Lopez acknowledged in an interview that he received a verbal request to remark the area of excavation from Kana Pipelines. Lopez stated that he referred the request to the City of Chino sewer department crew leader Cavalier, but that he never followed up to see if it had been done.

Gov't Code 4216.3(b) requires an operator to respond to a remark request made through the regional notification center within two working days, not including the date of notification, but Gov't Code 4216 *et al.* does not require the operator to respond to verbal remark requests. Therefore, the City of Chino Department of Public Works is not in violation of Gov't Code 4216 *et al.* Nonetheless, when the City of Chino Department of Public Works received the verbal

remark request from Kana Pipeline, they should have responded by either remarking the area of excavation or informing Kana Pipeline that Kana needed to contact the one call center to request remarks so all utilities with facilities in the area of excavation are notified and the request is documented.



I asked Miranda to explain the type of work Kana Pipeline was performing on this project and what in his opinion was the cause of the damage the occurred on November 20, 2020. Miranda stated that Javier Herrera (Herrera) who was also present during the interview was operating a 75K pound excavator, excavating a trench line to remove a CMP riser when he hit a forced sewer main with the bucket of the excavator. Miranda stated that the line was marked and the trench was already open. Miranda further stated and Herrera agreed that Herrera knew the line was there, but that his attention was temporarily diverted and he hit the forced sewer main with the bucket of the excavator. Miranda stated and Herrera agreed that the incident was the result of operator error and that Kana Pipeline takes responsibility for the incident.

Miranda stated that after the hit, Kana Pipeline contacted the City of Chino Public Works to advise them of the damage. Miranda further stated that the City of Chino Public Works came out with vacuum trucks to clean up and haul off the spilled sewage and repair the damaged line.

On July 27, 2021, I interviewed Enrique Miranda (Miranda), Director of Safety for Kana Pipeline about two (2) separate incidents on the same project that occurred on November 20, 2020 and January 13, 2021, involving utilities belonging to the City of Chino.

I asked Miranda to explain the type of work Kana Pipeline was performing on this project and what in his opinion was the cause of the damage the occurred on January 13, 2021. Miranda stated that Mike Lockwood (Lockwood) who was also present during the interview was the foreman for Kana Pipeline on this particular job. The excavator operator on this job was Rogelio Becerra (Becerra).

Miranda stated that Becerra had not worked on this section of the project until the day the incident occurred. He was brought over because he operated a large 160K pound excavator. Miranda stated that Becerra was there to dig a sewer manhole out for the installation of a sewer in a new development.

Miranda stated and Lockwood agreed that Kana Pipeline knew where the line was because it had been previously marked, but due to time and all the work being done in the area the marks were no longer visible. Miranda stated that Lockwood made several requests to have the line remarked. I asked Miranda who they contacted to have the line remarked. Miranda stated that they contacted the City of Chino who owns the utility and spoke with an inspector and IEAU the company who operates the line to have it remarked. Miranda Stated that after several attempts the Sewer Main was never remarked. Miranda stated that they knew where the sewer main was and that is was roughly 20 feet deep, so Lockwood directed Becerra to start to dig with the excavator. Miranda further stated and Lockwood agreed that after instructing Becerra to start excavating Lockwood walked to the opposite side of the job and wasn't close by to direct Becerra. Miranda stated that while digging for the manhole, Becerra was about 5'to 6' feet below grade when he hit the 16" inch forced sewer main. Miranda stated that after the sewer main was hit, Lockwood dug a pond to contain the sewage so it would not drain off to nearby vegetation and roads. Miranda stated the City of Chino was again contacted and they came out with vacuum trucks to clean up the sewage and repair the damage.

I asked Miranda if Kana Pipeline potholed the line prior to excavation. Miranda stated that no Kana Pipeline did not pothole the line since they believed they knew where it was and expected it to be 20 feet deep.

Lockwood stated that he felt some responsibility for the damage because he believed he was not 100% clear with Becerra about the actual location of the line.






### NARRATIVE:

On July 28, 2021, I interviewed Rick Lopez (Lopez), Inspector for the City of Chino about an incident involving Kana Pipeline that occurred on January 13, 2021.

I asked Lopez to describe in his own words what occurred that day. Lopez stated that this was a huge development project with a lot going on. Lopez further stated that Kana Pipeline was digging out a manhole for the installation of a new sewer line for a new development. Lopez further stated that Kana Pipelines excavator while digging for the manhole hit their 16" forced sewer main causing a leak of sewage. Lopez stated this was Kana Pipelines second hit on the sewer main on this project.

I asked Lopez if Kana Pipeline had called for a remark of the sewer main for this particular part of the job. Lopez stated that he did receive a verbal request to have the sewer main remarked and that he forwarded the request verbally to Joe Cavalier (Cavalier). Lopez stated that Cavalier was the crew leader for the City of Chino sewer department and would be in charge of marking the line. Lopez further stated that after he relayed the request to Cavalier he never heard anything else from Kana Pipeline about the remark request and assumed it had been completed. Lopez again stated that this was a huge project with a lot going on so he moved on to other things. When I asked Lopez for Cavalier's contact information, he stated that Cavalier no longer works for the City of Chino. Lopez stated that it should be noted that there are (2) 16" sewer mains running side by side and that they were clearly shown on the plans Kana Pipeline had been given. I asked Lopez about the depth of the sewer mains and he said that the grading was rough in several areas of the new development worksite, so it would be difficult to accurately determine the depth from the plans.

I asked Lopez who IEUA was and what their role is. Lopez stated that IEUA was the Inland Empire Utility Agency and that they run the sewage plant but the lines belong to the city. I asked Lopez if

they would be responsible for marking the line and he stated no they wouldn't have marked the line. Lopez further stated that they are the agency who came to clean up the spill.
