This letter confirms receipt of Horizon West Transmission, LLC's March 18, 2020 request for an extension regarding the above-referenced Data Requests. Showing good cause, the request is granted.

Due to the timeframe for submission of responses, WSD is reiterating the following guidance in order to prevent any further delays to the WMP review process:

Horizon West Transmission is expected to submit complete data responses by close of business March 20, 2020. Data requests responses should follow the instructions sent on February 26, 2020, as noted below:

- a. Clearly reference the "Item Index" in the response to each data request. This will ensure that utility responses are clearly targeted to specific data requests.
- b. For sections of the WMP where utilities are providing updates to existing text or data, or adding new text or data elements, etc., provide a version of the entire WMP in "track changes" format showing any changes relative to your WMP submitted on February 7. Also provide a version in clean copy.
- c. Updated WMPs must be served on the service list of R.18-10-007. The previously set deadline for Horizon West Transmission's submission is changed to March 31, 2020 to accommodate responses to this data request.
- d. For data requests that relate to Tables 1 through 31, or any other information provided in excel format, provide an updated version of the relevant table, highlighting cells with modified data in yellow and highlighting cells with new data in

green relative to the version submitted on February 7, 2020. For clarity, include a legend in the same excel file. Also provide a separate clean copy in excel format.

- e. Providing a "track changes" version is not applicable to GIS-focused data requests.
- f. For data requests that are not specific to a section of the guidelines, GIS files, or tables, please provide a response to the data request in the cell next to the data request on the excel table. Provide a link to an external document if required.
- g. Provide the files through Kiteworks in a folder labeled "utilityname_DR_20200226" with the "Item Index" and the data request date in the file name.

If Horizon West Transmission fails to submit complete responses to the data requests, by close of business March 20, 2020, it will be considered to be out-of-compliance with the data requests and Resolution WSD-001, unless Horizon West Transmission can demonstrate that it does not possess and cannot obtain the requested data.
