The Office of Energy Infrastructure Safety (Energy Safety) is hosting an initial scoping meeting for stakeholders, relevant state agencies, and California's electrical corporations to share ideas and discuss the inclusion of community vulnerability in wildfire mitigation planning.

Socially vulnerable communities can be disproportionately impacted by wildfires and may therefore experience more challenging paths to recovery. Utility wildfire mitigation planning does not consistently quantify impacts that may be exacerbated by social vulnerability nor take into account the factors in a community's ability to recover from a wildfire.

### Topics of discussion:

- What community vulnerability factors are key for wildfire mitigation planning?
- How can we measure these factors to inform decision making?
- What opportunities / challenges are there in applying community vulnerability to utility consequence risk modeling?
- What are other opportunities to bring community vulnerability into wildfire mitigation decision-making?
