2022 POU WMP Guidance Advisory Draft



- Structure and Scope
- Risk Modeling and Reporting
- Vegetation Management and Environmental Stewardship
- System Design and Operation: Grid Hardening
- Communications and Community Outreach

Structure and Scope

- Up front cohesive summary with graphics
- Use topical structure to help reduce redundancy
- Describe collaboration with relevant agencies
- Use links to include all relevant information in WMP while reducing length
- Separate Guidelines easing burden on smaller IOUs and ITOs





Risk Modeling and Reporting

- Avoid describing risks or model parameters as "unknown".
- Track notices of violations over time and report those requiring immediate correction
- Develop public maps showing risk probabilities, detailing by area mitigation efforts and showing where those efforts are focused.






Vegetation Management and Ecology



- Report on use of latest fire science, longer term changes in ecosystems that may increase hazards, unintended changes in conditions
- Energy Safety collaboration with agencies regarding tree removals and nearby vegetation management
- Expanded pilot programs for defensible space under utility power lines
- Report on use of herbicides and growth regulators



System Design and Grid Hardening



- Summary table for research efforts and pilot projects
- Specific response to lessons learned from prior fires
- Protocols for workforce safety with new technologies and practices
- Identify and report on idle but energized lines
- Report on status of legacy equipment



Communication and Community Outreach

- Describe linkage between outreach program direction from Energy Safety and other agencies
- Enhanced reporting on collaboration with local authorities and CBOs
- Report on outreach analytics, what is working
